

Terms & Conditions

Monthly Trading Competition

Introduction:

1. Doo Prime invites traders to participate in our **Monthly Trading Competition** (hereinafter the “**Competition**”) subject to terms and conditions contained herein (hereinafter the “**Terms and Conditions**”).
2. The client’s participation in this Campaign shall also be taken as the client’s consent to be legally bound by the Terms and Conditions herein and any of its subsequent amendments.

Campaign Period:

This Competition will be held monthly starting from **2nd January 2025 at 8:00 am UTC+2 and will run for 12 months** (hereinafter the “**Competition Period**”).

Eligibility:

This Competition is open to all new and existing clients (hereinafter the “**Client**”) and is subject to Doo Prime’s (hereinafter the “**Company**”) eligibility criteria as indicated in the [Client Agreement](#) and these Terms and Conditions. This Campaign would be **excluding Doo Prime clients from China, Hong Kong, Macau, Taiwan, Korea, Japan and EEA countries.**

Participation:

1. New and existing clients- To participate in the Campaign clients must follow the steps mentioned below.
 - a. Clients must complete verification and be successfully onboarded as the Company’s clients.
 - b. Click on the promotion tab in the client area.
 - c. Select the Monthly Trading Competition tab, review and accept the terms and conditions to participate in the Competition.
 - d. To be eligible for the Competition Clients must make a minimum deposit of USD250 into their trading account within the desired month that the client wants to participate in the competition.
2. To participate in the following month, the Client would have to make a new deposit of USD 250 into their trading account within the desired month that the client wants to participate in the competition.
3. This Competition will calculate the **volume in USD** of all the trades that are opened during the Competition Period and closed during the Competition Period for each Client.
4. If there are two (2) Clients with the same volume in USD, the Client with the higher number of lots will be the winner of the reward.
5. Only Cent, ECN and STP account types are eligible to participate in the Competition.
6. PAMM/Gold-i MAM accounts are excluded from the Competition.
7. The use of Expert Advisors and CopyTrading is allowed for trading.

8. Only lots of closed orders of Doo Prime products will be calculated **excluding lots of U.S., Hong Kong, Australia stocks, cryptocurrency and mini spot indices.**

About the Reward(s):

1. The reward of **USD500** will only be distributed to the client with the highest volume in USD for that month.
2. The winner of the month will be selected in the first week of the following month. For example, if the Competition starts on 1st January 2025, the winner will be selected in the first week of February 2025.
3. The winner will be announced in the second week of the following month. For example, if the Competition starts on 2nd January 2025, the winner will be announced on the second week of February 2025.
4. The winner will be contacted by Doo Prime Support team via the email that was given during registration. The winner would have to respond to the email by acknowledging the email received.
5. The reward will be sent to the winner's wallet in the form of balance within 3 working days of receiving a response from the winner.
6. The reward amount can be withdrawn.

Terms and Conditions:

1. Withdrawals during the Competition Period are allowed.
2. The Company reserves the right to adjust Clients' leverage when the Client is suspected or found abusing the leverage. **Abusive behavior is considered (list not exhaustive):** Multiple registrations from the same IP address, multiple profiles, trading activities that can be considered as fraud, manipulation or attempts to garner risk free profits, the participation to the Competition of third parties on behalf of the Client, trades entered or exited with latencies.
3. All Employees, Management and Board of Directors of the Company are restricted from participating in the Competition.
4. A leaderboard of the top 10 clients will be available for all clients to check their current ranking. The information on the leaderboard will be updated once a day.
5. In case of any dispute, the decision of the Company shall be final and conclusive.
6. By participating in the Competition all Clients are deemed that have read, fully understood and agreed to these Terms and Conditions. The right of consideration belongs to the Company only.
7. If the Client is suspected of any fraudulent activity, including unusual profits from the exploitation of the trading system vulnerabilities, trading error on any brokerage system, virtual money or breach of market principles, the Company has the right to forfeit all rebates, profits, and credits. In any case of dispute, the Company's judgement is deemed final.
8. The Company reserves the right, in its sole and absolute discretion, to suspend, withdraw



and/or terminate this Competition if acts of fraud or deception are detected, including but not limited to improper profit making by using flaws or loopholes in the trading system or broker's system for quotes, virtual funds, other violations of market fairness principles ("Disrupting Event") corrupts or impairs the administration, security, fairness, judging, or proper play of this Competition.

9. The Company reserves the right to make all absolute decisions regarding all aspects of the Competition and reserves the right to change, modify or withdraw any Competition related Terms and Conditions, including but not limited to Competition rules, Competition Period and reward amount, without prior notice.
10. These Terms and Conditions are written in English and may be translated into other languages. In the event of any inconsistency between the English version and a translated version of these Terms and Conditions, the English version shall prevail.
11. The Clients fully understand the risks of trading with the respective financial instrument before engaging in any transactions with The Company. The volatile nature of the Forex market means that there is a possibility of substantial losses, and past performance is not indicative of future results. The Company shall not be liable for any loss or damages as a result of the Client's failure in understanding the risks described in [Risk Disclosure and Acknowledgement](#) and the trading risks undisclosed.
